Copyright Policy and Course Programme Copyright Statements

Rationale

The Globethics.net Academy Copyright Policy and the course programme Copyright Statements are offered to provide clarity and transparency on the use of material made available to registered course participants on the Academy's learning management system. The Globethics.net Academy recognises and respects the intellectual property of authors and strives to adhere to international standards to protect intellectual property rights.

At the same time, Globethics.net endeavours to contribute to a culture of learning that assists course participants in embracing and applying best academic practices, such as the referencing of sources and conventional quotation rules, to which copyright regulations are by extension associated with.

Internal Implementation Guidelines

- The present Copyright Policy shall be made available and accessible for staff, course participants and instructors on the learning management system (Course documentation);
- An introduction to the Copyright Policy shall be made part of course instructor's introduction sessions and/or general orientation sessions for each course;
- The Course Programme Copyright Statements are to be placed with the complementary copyright notice at the bottom of the title screen of every course programme, or alternatively in a dedicated "About this programme" section; and
- For course programmes that are subdivided into several modules (see for example the Interreligious Cooperation for Peace course), the Course Programme Copyright Statement will be placed at the bottom of the title screen of each course programme module (part).

- (5) Apart this use, no material from the course programme provided on the Globethics.net Academy learning management system may be copied, reproduced, posted, distributed or re-published without the written and express permission of the copyright holder.

Furthermore, the Globethics.net Academy, supported by its team of course instructors, encourages the application of academic conventions with regard to the quotation of sources and bibliographic references as suggested in the Globethics.net Publications Style-guide.
